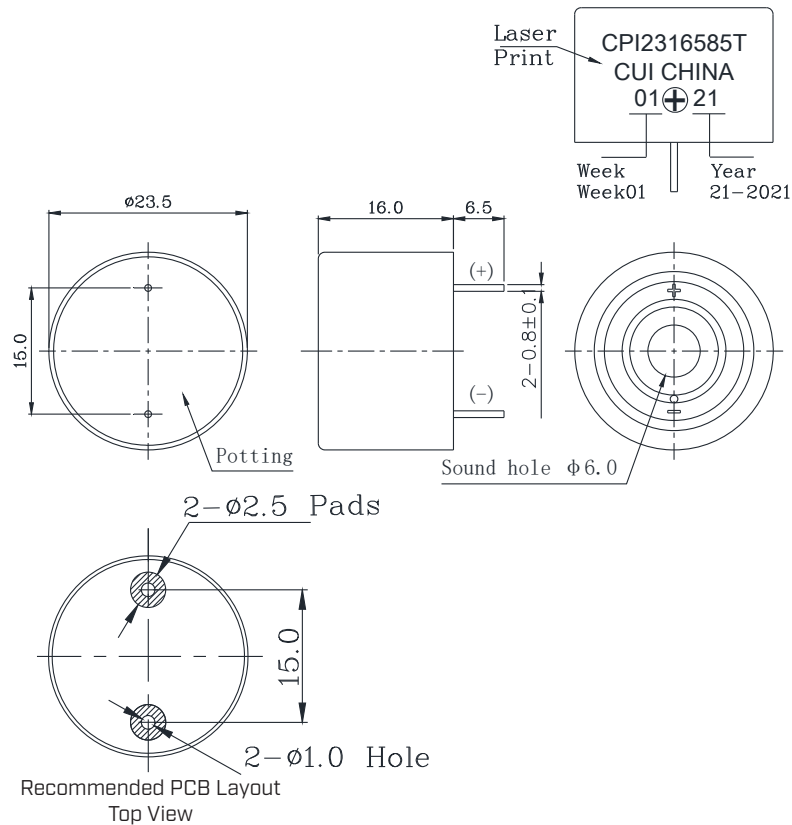

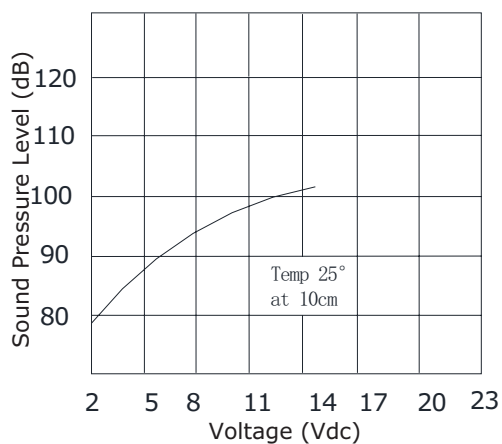

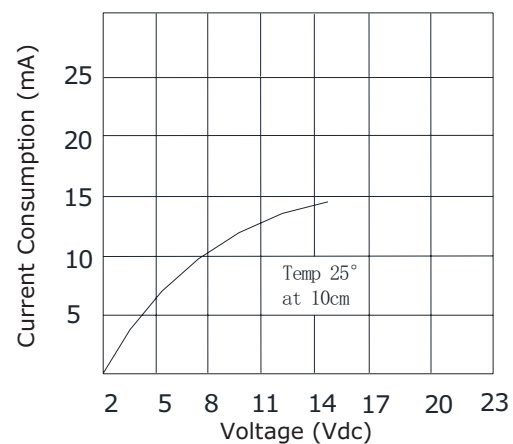


PERFORMANCE CURVES

at 10 cm, 25°C



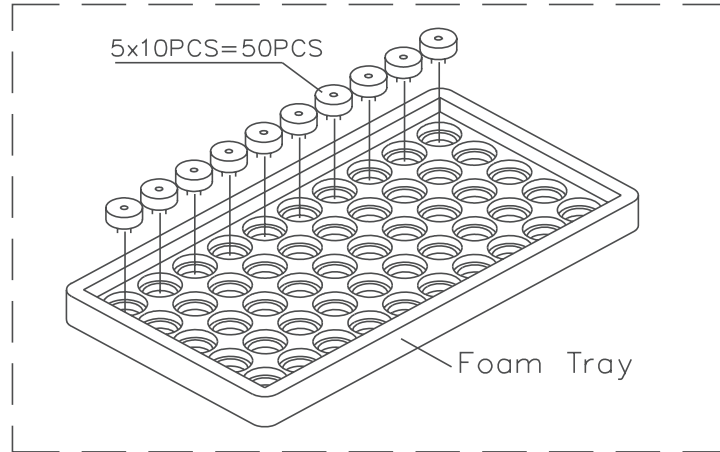
Voltage vs. Current Consumption

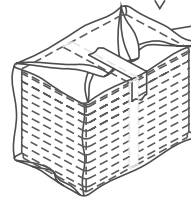
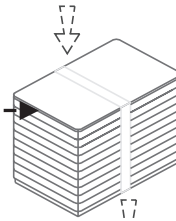
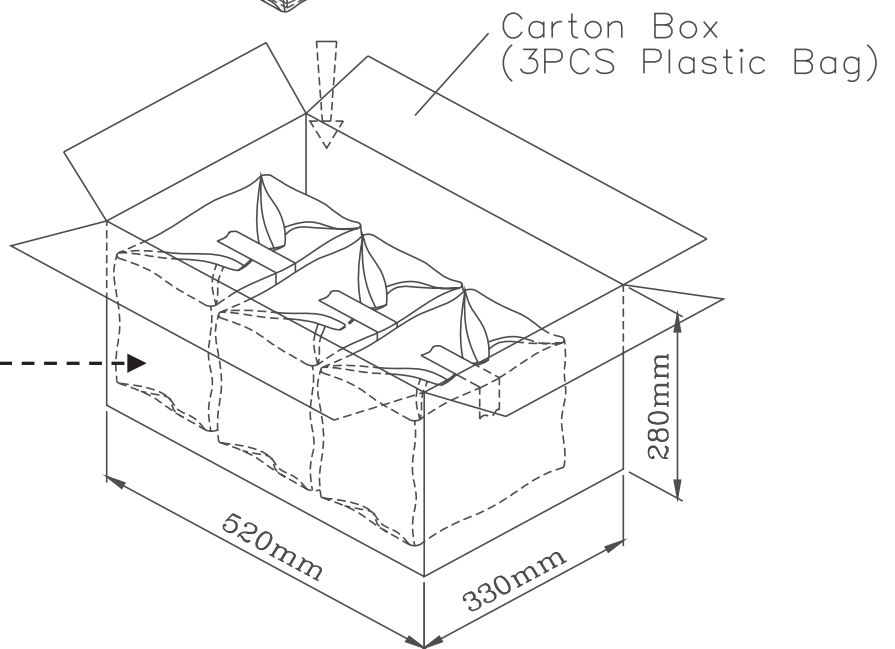
