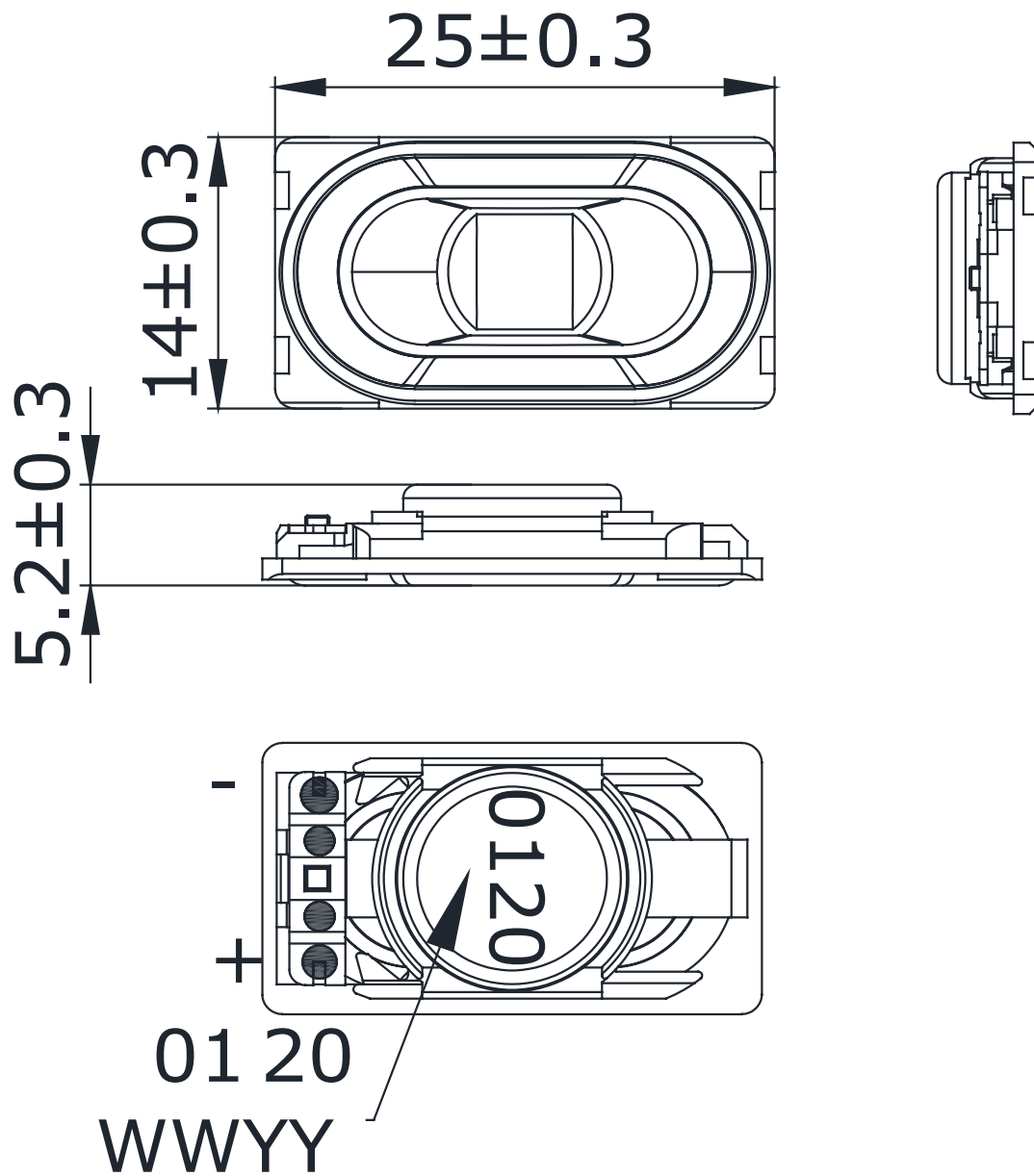

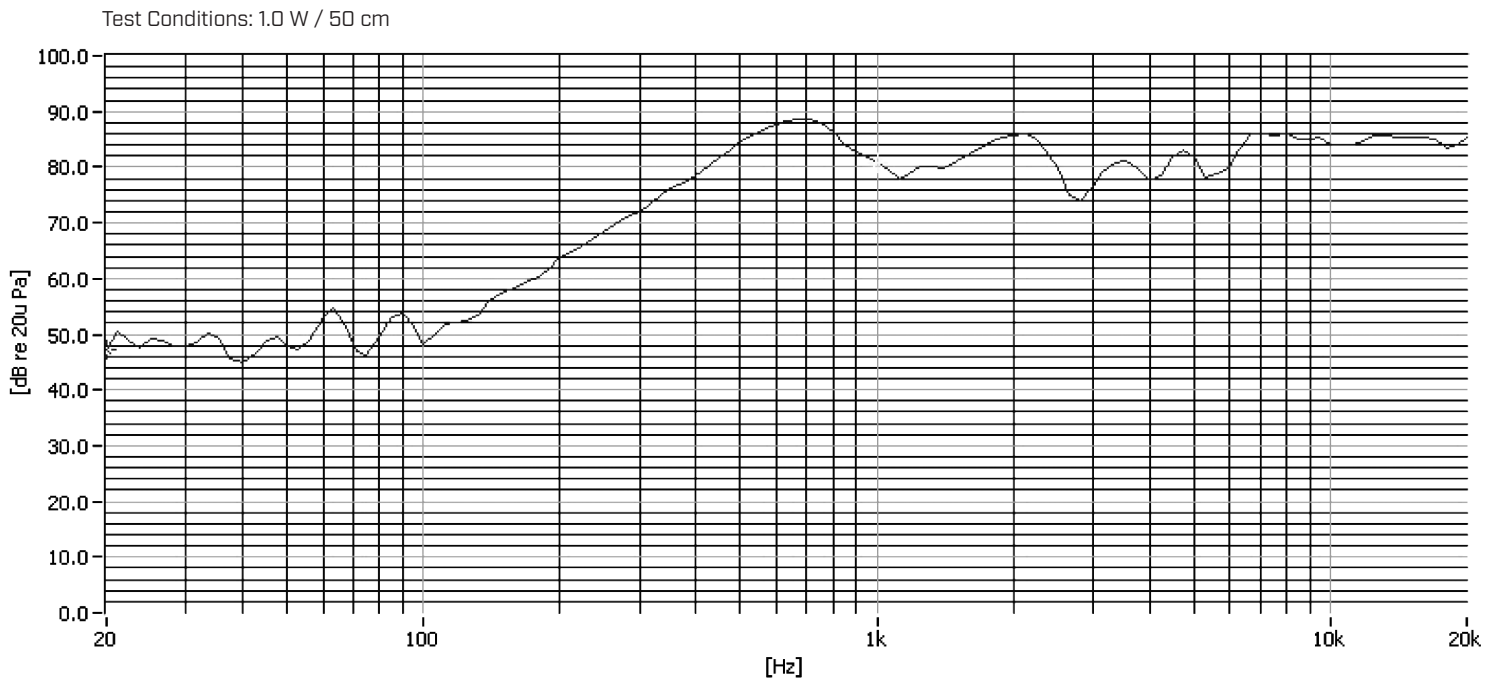

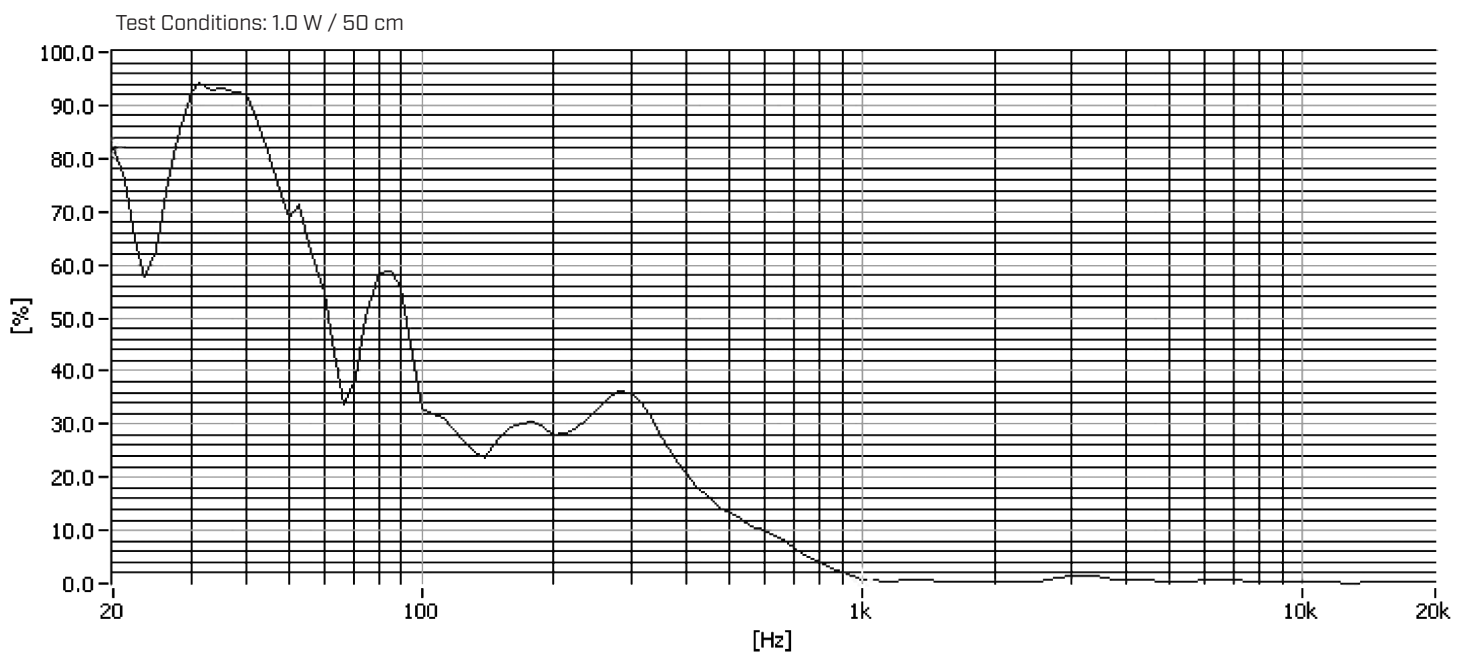


RESPONSE CURVES

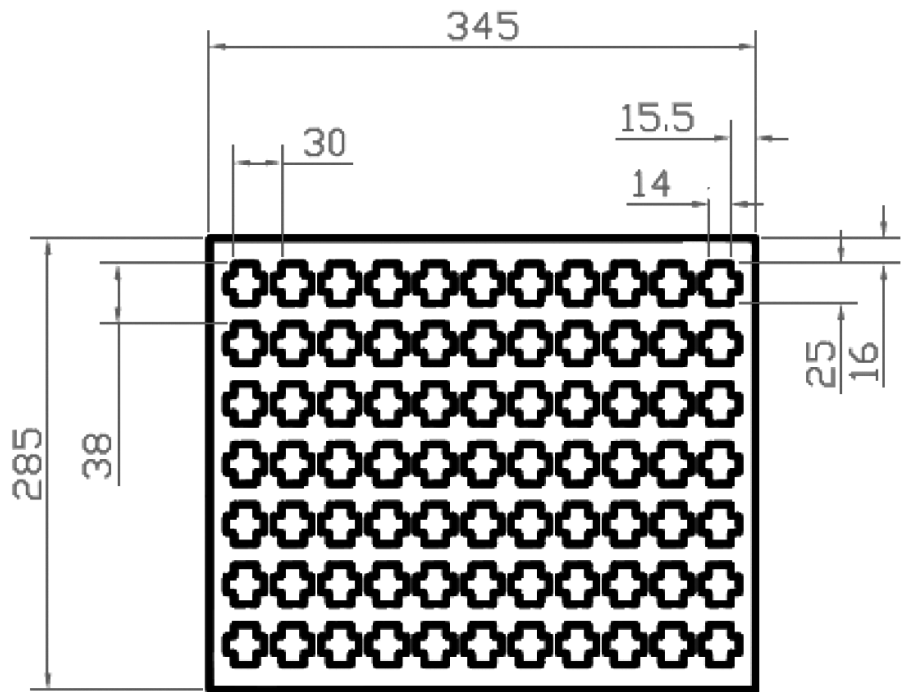
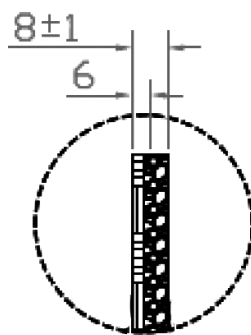
